Kick-off agenda:
The kick-off included both the project partners and external stakeholders interested in the topics. The kick-off lasted around 4 hours, and took place in person at the premises of SABA RH.
The first 2 hours were dedicated to presenting the project to different stakeholders interested in the topics, in order to engage them directly in the project planning and implementation and increase the visibility and communication strategies of the project from its beginning. The interested parties commented on relevant topics to be included in research efforts; shared their experience and expertise.
After that, the project partners held a close meeting in which they discussed in detail administration and technical aspects of the proposal, including the budget division; respective tasks; timelines; and communication and dissemination strategies.

3) Minutes of the meeting

The meeting was held on Monday 8.4.2024. starting at 10:30 am. To the meeting took part representatives from the Association of Anti-Fascist Fighters and Anti-Fascists of Croatia (SABA RH), the Association of Joint Fighters for the Values of the National Liberation Army of Slovenia (ZZB NOB SI) and the National Alliance of Partisans of Italy (ANPI Trieste), and *Documenta* - Center for dealing with past. During the meeting, the partners discussed the implementation of the CERV project entitled "Position and role of the victim".

The purpose and goal of the project is to use various educational, research and public popularization activities to point out different criteria when assessing the role and position of the victim in the Croatian, Italian and Slovenian society. The emphasis of the project will be on the victims of the wars that took place in the 20th century on the territory of the three mentioned countries.

In all the partner countries, different criteria are visible when evaluating "our" and "their" victims, civilian and military, as well as victims of certain historical events. The project will also show various examples of abuse of victim "status" for political and nationalist purposes. Examples from historiography speak of this in the sense of emphasizing some and ignoring other victims, but also of everyday life, for example, the renaming of streets or schools, and monumental heritage.

In the meeting, the partners discussed their roles and obligations during the project. Each of the partners will organize a School of Democracy, whose participants will then take part in an education youth camp, to be held in Croatia. Each partner will also conduct a research. The topics of the research will be the Holocaust, genocide

and the suffering of people in wars and totalitarian regimes, starting from the premise that the victim is equal on all sides. In addition to the use of materials, media and interviews with the victims, visits to the places of suffering were also included in the research. Research activities should include a round table on the position of victims in today's societies and a pan-European media campaign.

The coordinator from SABA RH presented the details of the project. Each school of democracy will consist of three modules. The school requires a minimum of 25 participants in each country, of which 15 are women, aged 18 to 30. In the first module, the position of the victims since the Second World War would be dealt with, in the second the memorialization practices, and in the third the trauma of the victims, from the (non)payment of compensation to trials for war crimes.

By May 1, 2025, the participants should present the results, experiences and research problems for a total of about a hundred peers, which will be included in the report.


